Synnex CSP Upskill Rewards

As part of our ongoing commitment to continuously empower and enable our partners, partners that successfully pass eligible Microsoft certification exams during the program period will receive a subsidy on their exam fee.

Program Period	01/07/2025 to 31/12/2025
Eligible Exams	Refer to full certification exam eligibility tables
Claim Submission	Claims must be submitted before 31/01/2026 to be eligible

Terms and Conditions:

- To make a claim, visit the **Synnex CSP microsite** (csp.synnex.com.au/upskillrewards).
- Partner must submit the following document for exam fee subsidy (refer to the **Appendix** for examples):
 - Microsoft certification
 - Exam booking tax invoice
 - A tax invoice from the Partner to Synnex with the subsidised amount
- Only successful exam is eligible for claim. Non-exam item such as add-ons, practice exams, retakes etc. are not eligible. Partner must supply the correct supporting documents for each eligible exam.
- The subsidy amount to Partner will be fixed using AUD currency.
 - **An exam fee of USD \$84 = AUD \$150 ex GST**
 - **An exam fee of USD \$140 = AUD \$250 ex GST**
- Partner must have a minimum of \$500 ex invoiced of CSP service with Synnex for the program period.
- Partner must be 100% payment compliant for all their Synnex invoices to qualify.
- The fixed subsidy amount will decrease if a discount code has been applied.
- Partners can and are encouraged to apply for this program multiple times to continuously upskill their team.
- Synnex is not liable for failed delivery due to incorrect information supplied.
